ADDENDUM TO THE SETTLEMENT AGREEMENT

- A. WHEREAS**, the Parties entered into a Settlement Agreement on April 27, 2023 to settle the class proceeding commenced in the Superior Court of Quebec under Court File No. 500-06-001051-206 (*Blondin c. Coloplast Canada Corporation*);
- B. WHEREAS**, the Parties sought the approval of the Settlement Agreement during the hearing held on September 6, 2023;
- C. WHEREAS**, during said hearing, and further to the Fonds d'aide aux actions collectives' submissions, the Parties agreed to modify section 4(2) of the Settlement Agreement through the present Addendum;
- D. NOW THEREFORE**, the Parties stipulate that the following constitute an amendment to section 4.2 of the Settlement Agreement dated April 27, 2023.
1. Section 4(2) reads as follows:
 - (2) From each payment owed to Settling Claimants, the Claims Administrator shall distribute, by cheque, the sum determined by the Special Master, after payment of the following:
 - (a) any taxes required by law to be paid to any governmental authority if any; and
 - (b) any sum owed to the *Fonds d'aide aux actions collectives* pursuant to the *Act respecting the Fonds d'aide aux actions collectives*, CQLR c F 3.2.0.1.1.

2. Section 4(2) of the Settlement Agreement is hereby amended to read as follows:

(2) From each payment owed to Settling Claimants, the Claims Administrator shall distribute, by cheque, the sum determined by the Special Master, after payment of any sum owed to the *Fonds d'aide aux actions collectives* pursuant to the *Act respecting the Fonds d'aide aux actions collectives*, CQLR c F 3.2.0.1.1.

3. All the other clauses and schedules of the Settlement Agreement remain unchanged, and this Addendum and its recitals are an integral part of the Settlement Agreement.
